# Efficiently track and deliver employee competencies and training on-board vessels with limited connectivity.

Carnival UK, a subsidiary of the largest cruise operator in the world Carnival Corporation & plc group, owns and operates the P&O Cruises and Cunard Line cruise brands in Southampton, UK. They operate a combined fleet of 11 ships with over 25,000 employees.

Carnival UK had very specific competency management requirements due to their large workforce, multiple types of vessels and disconnected operating environment. They needed a system that could effectively track personal development records (PDRs), deliver competency-based training and work seamlessly on-board vessels with limited Internet connectivity. Carnival UK's complex organizational structure and workflows also required extensive customization and dedicated support.

# **Challenges:**

- Digitize the process for creating, delivering, tracking and managing competency checklists (Professional Development Records) across all marine operations roles
- Document, organize and deliver a catalog of learning materials and courses on an online system
- System must work in an environment on-board vessels where Internet connectivity is limited or non-existent
- Custom user interface, configurations and workflows to match complex organizational structure: multiple vessels, departments, roles and brands under the Carnival UK umbrella

## **Marine Learning Systems at Carnival UK**

Carnival UK's goal was to implement a competency management system that worked on-board vessels. Their Personal Development Records (PDRs), which are checklist records of competency, were originally tracked through various, disparate tools. With a diverse fleet of vessels and 36 PDRs for each rank, there were over 600 different PDRs across the marine operations department. A competency management tool was needed to centralize information and streamline the process of managing PDRs.

Shore-based systems were unable to provide a reliable, working solution on-board Carnival UK's vessels due to limited Internet connectivity out at sea. Based on proven success with maritime operators in delivering a system that could work seamlessly both on-board vessels and on-shore, Marine Learning Systems was chosen to provide Carnival UK with MarineLMS and Remote Training Servers (RTS) to manage their PDRs.

Marine Learning Systems relied on their extensive LMS development and implementation experience to complete numerous software customizations during the deployment phase: from generating custom registration rules and loading all PDR checklist requirements, to custom UI and auto-notification triggers that matched Carnival UK's specific processes and workflows. The professional services team consistently met all deadlines and deliverables, allowing Carnival UK to go live with their system within 3 months.

MarineLMS is now used to deliver, manage and track PDRs for all marine operations, electrical engineer, medical and environmental officers. Usage has also expanded to include online training for the Deck and Technical department, Environmental training and Onboarding training for new
